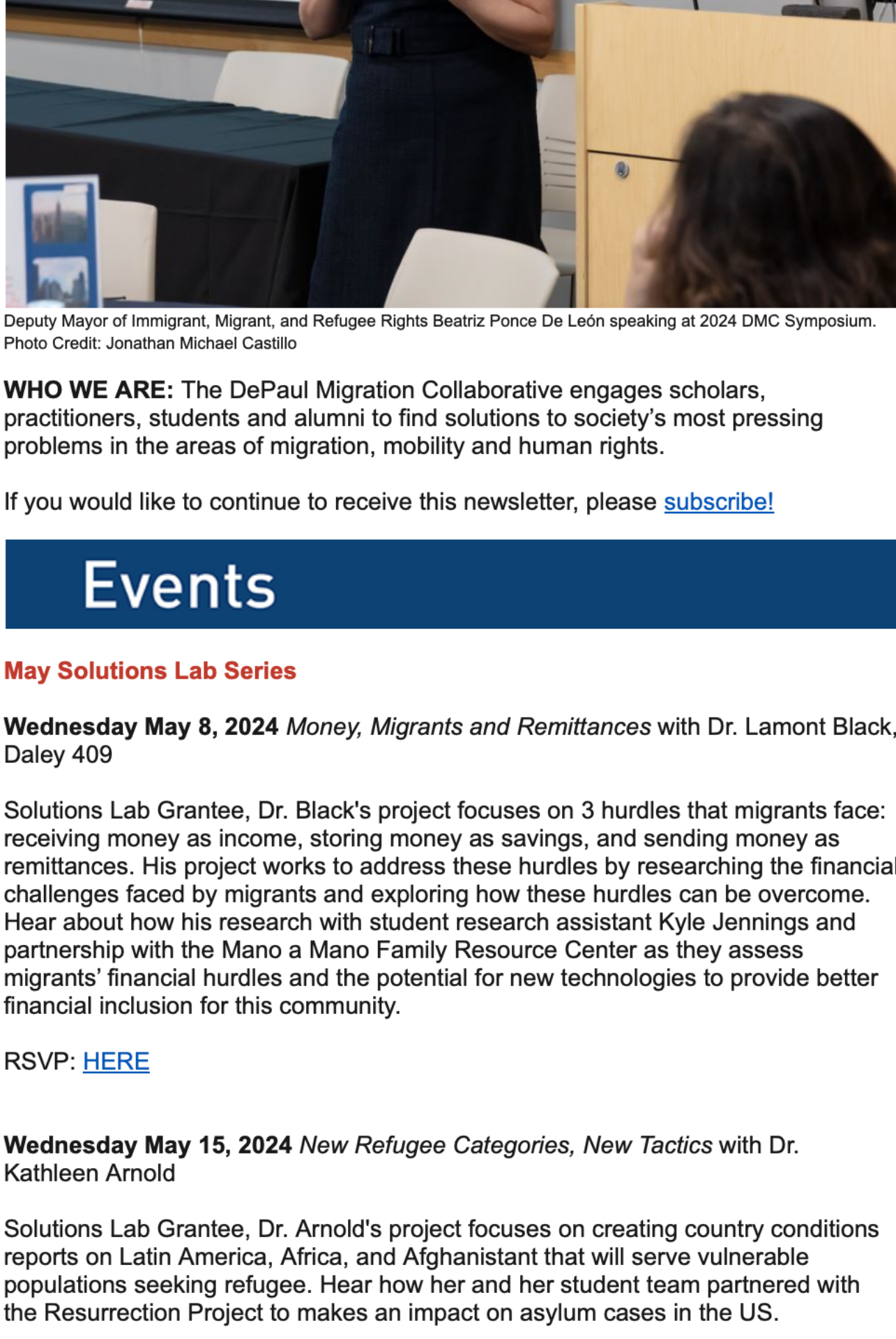

### May Solutions Lab Series

**Wednesday May 8, 2024** *Money, Migrants and Remittances* with Dr. Lamont Black, Daley 409

Solutions Lab Grantee, Dr. Black's project focuses on 3 hurdles that migrants face: receiving money as income, storing money as savings, and sending money as remittances. His project works to address these hurdles by researching the financial challenges faced by migrants and exploring how these hurdles can be overcome. Hear about how his research with student research assistant Kyle Jennings and partnership with the Mano a Mano Family Resource Center as they assess migrants' financial hurdles and the potential for new technologies to provide better financial inclusion for this community.

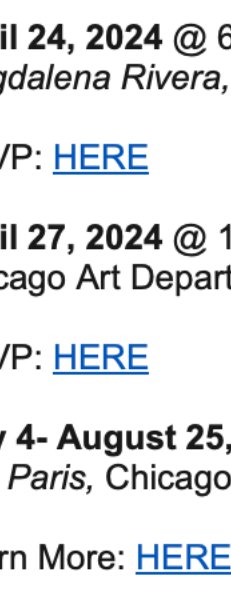
**Monday May 22, 2024** *Building Resilient Programs to Serve Refugees* with Dr. Kate Cooper

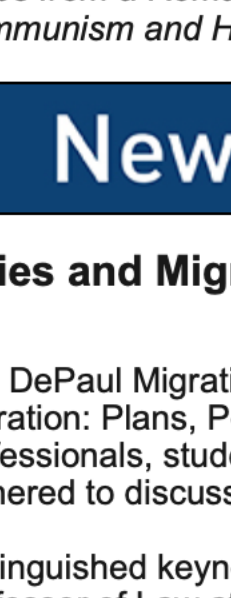

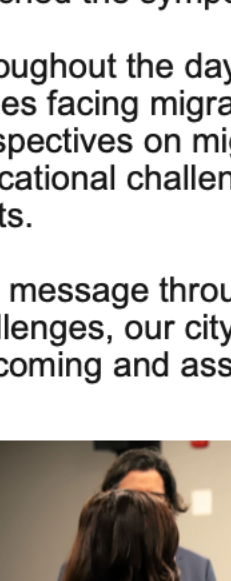
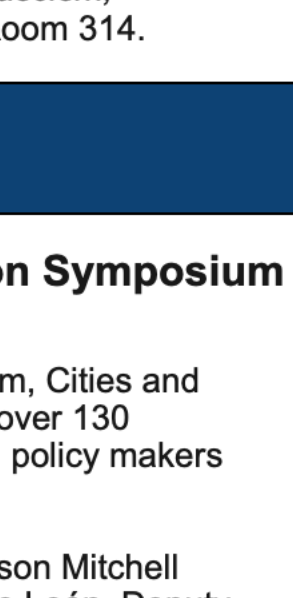

### Cities and Migrations: Plans, Policies, and Action Symposium

The DePaul Migration Collaborative hosted the 2024 Symposium, Cities and Migration: Plans, Policies, and Action on April 11 which hosted over 130 professionals, students, attorneys, direct-service providers, and policy makers gathered to discuss the role of cities in migration.

Distinguished keynote speakers Jennifer Chacón, the Bruce Tyson Mitchell Professor of Law at Stanford Law School, and Beatriz Ponce De León, Deputy Mayor of Immigrant, Migrant, and Refugee Rights (IMRR) for the City of Chicago, enriched the symposium with their insights.

Throughout the day, guests picked between seven incredible panels that explored issues facing migrants in urban communities. These panel discussions offered perspectives on migration's complexities, spanning legal hurdles, access to shelter, educational challenges, healthcare access, data management, and workplace rights.

The message throughout the symposium was clear: Though we face many challenges, our city (and our country!) is full of dedicated people who are committed to welcoming and assisting our new neighbors.

### DMC Brings Together City Leaders to Discuss Illinois Response to New Arrivals



With the release of his newest report, "Building a Plane While It's Flying": Illinois Confronts a New Era of Forced Migration" DMC Practitioner in Residence, Rob Paral, led a fruitful discussion with non-profit leaders and representatives of the City of Chicago. Rob Paral's report is a demographic analysis of Chicago's recently received forced migrants from regions like Ukraine, Afghanistan, and Venezuela amongst others with recommendations on how the state can better serve its new neighbors. Each participant of this community roundtable shared their opinions on the report and offered their expertise, experiences, and action taken by their organizations. Over 30 individuals participated to brainstorm what is next for Chicago. They concluded by acknowledging that this work is not just about new arrivals, but all marginalized communities in Chicago and state, city, and local programming must reflect this. They explained how there is a need for new innovative tools to assist in communications and cross-organization collaboration and coordination. Participants also highlighted that this discussion requires additional input from the migrants themselves and seek to include our new neighbors in future program analysis.
