



Paula has been awarded the 2022 Essay Prize in Latin American Thought by The APA Committee on Hispanics/Latinxs in Philosophy for her essay, "The Theater of Knowledge at the Zero-Point as a Colonial Enterprise: Santiago Castro-Gómez's Engagement with Kant." The selection Committee commended Paula for her excellent contribution, which they found innovative, rigorous, and the very best representative English-language essay in Latin American Thought of 2022.

The APA committee on Hispanics/Latinxs sponsors the annual Essay Prize in Latin American Thought, which is awarded to the author of the best unpublished, English-language, philosophical essay in Latin American thought. The purpose of this prize is to encourage fruitful work in Latin American thought. Eligible essays must contain original arguments and broach philosophical topics clearly related to the experiences of Hispanic Americans and Latinxs. The winning essay will be published in the APA Newsletter on Hispanic/Latino Issues in Philosophy .



SUCCESSFULLY DEFENDED DISSERTATIONS

M.Kemal Isik

Kemal successfully defended his dissertation, "Eleusis contra Delphi: The Idea of Eternal Return in Nietzsche, Heraclitus, and the Greek Mystery Cults," on September 26th, 2022.



"Kemal's dissertation excavates broadly in Greek culture, religion and religious practice, literature, and philosophy to uncover a consistent emphasis on and especially a contentment with human finitude, in connection with a certain experience of time. Indeed, it traces the shifting meaning of the Greek term *aiôn* or 'eternity, lifetime, age' over the whole of the Archaic and Classical periods.

And to this it adds an impressive treatment of the contours of the Nietzsche's tragic philosophy, showing the way the thought of the eternal recurrence of the same emphasizes and confronts the reader with the finitude of human life, power, and understanding. Finally, in a synthesizing move it is hard to imagine anyone but Kemal daring to make, the dissertation demonstrates the deep and substantive affinity between these two temporal ideas, *aiôn* and Eternal Recurrence, and establishes the strong likelihood that Nietzsche's early philological study of the former was an influence on and inspiration for his later thinking of the latter. "

Cameron successfully defended his dissertation, "Aristotle on the Concept of Life," on November 21st, 2022.



"Cameron's dissertation, Aristotle on the Concept of Life, offers a new and profoundly illuminating approach to Aristotle's ontology of life. In it, he succeeds in resolving what has been a major problem for scholarship on Aristotle, namely the seemingly non-univocal character of the concept of life, which is at the very center of Aristotelian psychology, biology, and even metaphysics. It will doubtless be a scholarly contribution of great importance."

Eric Aldieri

Eric successfully defended his dissertation, "Loving without Memory: Immanent Soteriology from Deleuze's Spinoza to Spinoza's Deleuze", on December 2nd, 2022.



Eric Aldieri's dissertation offered a profound study of a largely neglected dimension of Deleuze's work, his epistemology, through an innovative analysis of the problematic of soteriology in his thought. Eric argued that a sustained engagement with Spinoza's famous three types of knowledge provides a key to tracking the development of Deleuze's account of knowledge of difference as impersonal and immanent, yet salvific. The committee found both the work and the defense to be exceptionally impressive and, as such, the project passed with distinction.
