## COLLEGE OF LAW FACILITIES

---

Located in Chicago's legal and financial district, the College of Law occupies ten floors of both DePaul University's Lewis Center, 25 East Jackson, and O'Malley Place, 23 East Jackson. The majority of law classrooms are on the eighth and ninth floors of the Lewis Center with additional classrooms located on the second and third floors of the Lewis Center and O'Malley Place.

The Office of Admissions and Pusateri Welcome Center are located on the first floor of the Lewis Center. Located on the fifth floor of the Lewis Center is a computer lab, which is equipped with the latest systems technology. Through our wireless network, students with laptop computers can access the internet from anywhere in the law school, including the library, classrooms, student lounge and student organization offices.

The student services suite, which houses the Office of Professional and Career Development, the Office of Academic Success and the Bar Passage Program, is located on the third floor of the Lewis Center. The Office of Student Affairs and the academic advising team as well as the Office of the Dean are located on the ninth floor of the Lewis Center. The library is located on the fourth, fifth and sixth floors. Clinics are located on the tenth floor and the externship director's office is on the eighth floor. Faculty offices occupy the sixth, seventh, and eighth floors of O'Malley Place, as well as the third floor of the Lewis Center and O'Malley Place. The Lawyering Skills Center, which includes the Leonard Ring Courtroom and the Robert Clifford Seminar Room, is located on the sixth floor of O'Malley Place. The Student Union, which houses student organization offices, student journal offices and the student lounge, is located on the second floor of the Lewis Center and O'Malley Place.

Though all law classes are held in the Loop, students commuting from the suburbs, or other parts of the city, are also free to utilize DePaul's Lincoln Park campus.
